### YOUR RIGHTS AS THE DATA PRINCIPAL IN INDIA

**1. Right of Access**

You have the right to obtain information from the data fiduciary about their personal data, the processing of it, and the identities of any third-party data fiduciaries or data processors with which it has been shared.

**2. Right to Correction**

You have the right to request correction of errors or omissions, or personal data updated.

**3. Right to Erasure**

You have the right to request the deletion of your personal data as promptly as reasonably possible, including data held or processed by third-party data processors, with certain exceptions. Please note that this is not equivalent to the comprehensive "right to be forgotten" under the GDPR.

**4. Right of Grievance Redressal**

You have the right to report a grievance at [dpo@testingxperts.com](mailto:dpo@testingxperts.com).

**5. Right to Nominate an Agent**

In the event of death or incapacitation, you have the right to designate someone to represent the data principal and exercise their rights under the Act on their behalf.

### ADDITIONAL INFORMATION

- i. Data principals do not have the right to data portability.
- ii. Data principals do not have the right to opt out of automated decision-making.
- iii. Data principals do not have a private right of action to sue a data fiduciary in the event of a breach. However, they may seek compensation for a breach from responsible parties.

### CROSS-BORDER DATA TRANSFER
